Dear Administrator Oz,

We write as manufacturers, suppliers, and support service companies working together to ensure access to durable medical equipment (DME) and home medical technologies for millions of Americans every day. Together, our companies employ tens of thousands of workers across all 50 states, in family-owned businesses that have served their communities for decades and in larger companies that have invested in American innovation, engineering, and manufacturing.

For generations, our industry has made it possible for seniors, veterans, and people with disabilities to live safely and independently at home. We take great pride in that mission and in the quality of the jobs we provide in towns and cities throughout the country.

We had hoped to work collaboratively with CMS on the Competitive Bidding Program as we did successfully with the previous Trump Administration on prior versions of the program. However, the Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program/Home Health Proposed Rule (CMS-1828-P) was developed without meaningful consultation with the providers, clinicians, and patient advocates who know this field best. Many of the assumptions embedded in the proposal are not only outdated but risk unfairly maligning the very people and companies who have devoted their careers to caring for Medicare beneficiaries.

We share your goal of stopping waste, fraud, and abuse. Compliant DME companies like the ones signing this letter are among the strongest allies CMS could have in that effort. We have long supported targeted solutions such as prior authorization, accreditation reform, electronic prescribing, and enhanced oversight of new suppliers by utilizing tools that strike directly at the bad actors while protecting compliant businesses and patient access. This approach risks penalizing compliant providers while failing to deter fraud.

The proposed rule would re-impose methodologies abandoned by the previous Trump Administration after extensive consultation with industry and Congress because they proved unworkable, including the use of lead-item bidding and the removal of financial-capacity safeguards. It would also subject sensitive product categories such as ostomy, urological, tracheostomy supplies, and continuous glucose monitors to an auction framework ill-suited to clinically customized or technologically advanced products. These changes would destabilize an industry that has already achieved price equilibrium and efficiency, leading to fewer suppliers, reduced access for rural and medically fragile patients, and the loss of thousands of American jobs.

We were particularly troubled to hear recent public remarks suggesting that fraud within the DME sector justifies a sweeping regulatory response. The reality is that the bad actors behind recent Medicare scams are not part of our system; they operate outside of it, exploiting weak enrollment standards and stolen beneficiary data. Conflating their misconduct with the work of long-standing, accredited suppliers is inaccurate and demoralizing to thousands of legitimate businesses that do things the right way.

The DME sector plays a critical role in the healthcare continuum by helping reduce the incidence of hospitalizations and other expensive clinical interventions, speeding hospital discharges, and providing a lifeline for seniors and people with disabilities, especially in rural communities. The DMEPOS provisions in the Proposed Rule threaten to further constrict a DME supplier base that has seen 36% of individual supplier locations close since 2013 and limit our industry's ability to provide this cost-effective form of care.

Dr. Oz, you have often said that industry knows its business better than government and that lasting solutions come from partnership, not punishment. We couldn't agree more. When CMS partnered with our industry under the prior Trump Administration, together we built the most sustainable, patient-focused version of the competitive bidding program to date. That collaboration produced guardrails that restored stability, rewarded quality, and ensured fiscal discipline without sacrificing patient access or domestic production.

We respectfully urge CMS to withdraw or delay the DMEPOS provisions of CMS-1828-P and re-engage with industry, patient, and clinical stakeholders to design an evidence-based, fraud-resistant, America-First framework. A renewed partnership that enlists those who build, distribute, and service this equipment will yield far stronger results than a rule developed in isolation.

Our companies stand ready to work with you and your team to strengthen integrity in the Medicare program while keeping care close to home and preserving the proud American businesses that make it possible.
