


Durable Medical Equipment (DME) Represents Approximately 1.5% of Medicare Spending

MEDICARE NEEDS COST-EFFECTIVE SOLUTIONS

Medicare expenditures continue to rise in spit of flat-lined durable medical equipment (DME) spending. It is critical that cost-effective home- and community-based services are strengthened and protected as our nation prepares for the senior tsunami.

- Overall Medicare spending increased over 264% from 2003-2023.
- In contrast, DME grew at 62% of the rate of Medicare from 2003-2023.
- DME as a percent of Medicare spending declined from 2.13% in 2003 to 1.55% (\$15.9 billion) of the Medicare budget in 2023.¹

DME IS ESSENTIAL IN MEETING THE HEALTH CARE TRIPLE AIM

It is imperative that the United States invest in cost-effective solutions to meet the needs of a rapidly aging population. By 2040, the percent of people 85+ will double to 14 million,² and by 2060, almost a quarter of the US population will be 65+.³

DME is a critical component of home-based care with tens of millions of Medicare beneficiaries relying on DME, supplies, and services to manage their needs in a home setting. Homecare is:

- Patient Preferred 77% of seniors want to age in place⁴
- **Cost Effective** Home-based care is less expensive than institutional care^{5,6,7}
- **Maximizes Health Outcomes** Home-based care reduces admissions/readmissions and lessens trips to the Emergency Department⁸
